for the 2009 Breeding Season ("Present Breeding Season") as specified in this contract. This contract is subject to the following terms and conditions:

TERMS & CONDITIONS:

This contract is applicable if you have used 3 breeding doses on one Mare and still do not get your Mare in foal with VDL Frozen semen you purchased from the VDL agent Prima Equestrian. We will verify your purchase with VDL Stud.

This contract is live foal guarantee (foal is standing and nursing at 48 hours) with a return for the following breeding season 2011. A report is due no later than August 31, 2011 stating whether or not the mare is in foal.

The Mare must receive Rhinopneumonitis (equine herpes type I) immunizations at 5, 7 & 9 months of pregnancy and be dewormed regularly to be eligible for the live foal guarantee.

Prior permission from Prima Equestrian must be given before substitution of another Mare.

Navarone and Farrington semen is EVA negative.

Prima Equestrian will require a letter from the breeding veterinarian containing the following information:

- The Mare was bred on at least 2 different heat cycles, using all 3 doses of the frozen semen.
- The breeding condition of the Mare, including biopsy, culture and blood test results and ultrasound findings.
- Treatment that was used on the mare, including uterine flushes, hormones such as HCG and Ovuplants.
- Breeding history should be provided with this contract.
- That the Mare is considered breeding sound.

FRESH SEMEN COLLECTION SCHEDULE:

Semen will be collected Monday-Friday as possible and we will work around the show schedules as much as feasible. The Buyer must contact Majestic Gaits the day before to guarantee shipment. The Buyer should keep Majestic Gaits informed of the progress of the heat cycle of their mare. This will help Majestic Gaits ensure we will have semen ready for your Mare when needed. Majestic Gaits will try to accommodate requests as much as possible. We ship via Federal Express next day air, so we can only ship Monday through Friday. If possible, time your mare for breeding Tuesday through Saturday.

A copy of the mares' registration papers is due with this contract. We would appreciate a picture of the mare.

FEES:

1. Booking Fee: A nonrefundable-booking fee of \$300 is due with the signing of this contract. This contract does not need to be filled out and signed until the Mare is determined not in foal after the 3rd breeding dose of VDL Frozen Semen.
2. Collection Fee: The semen will be shipped fresh chilled in a disposable shipping container. Collection fees of \$175 per collection are due prior to shipment of the semen
3. Mare Surcharge: Every mare is required to pay the Dutch KWPN-NA additional \$75 mare surcharge whether they are registered with the KWPN-NA or not. If the mare is not in foal for the present breeding season, an additional \$75 surcharge will be due for the following breeding season. Any extra fees required by the registry of the foal will be charged back to the Buyer. The foal can only be registered with only one registry
4. Shipping costs: We ship via Federal Express will be charged to the Buyer. A credit card or Federal Express account should be provided to cover these costs

If fresh semen becomes unavailable for breeding within the 2 breeding years of this contract the fees are not refundable.

All fresh semen fees must be paid prior to any semen being shipped.
